The Fallon County Transportation Program's fleet consists of two cutaway vans, one 12 passenger and one 13 passenger. Each vehicle is handicapaccessible and both are equipped with wheelchair lifts and two wheelchair stations. We also utilize a 6 passenger mini van and a 6 passenger SUV style vehicle.

The suggested donation per round trip for a local ride is \$1 for those individuals over the age of 60. A specific fare is required of those individuals under the age of 60.

Priority Service

It is the policy of the Fallon County Transportation Program to provide rides on a demandresponsive system with no one individual receiving preferential treatment regardless of age or disability.

Service Area

Our vehicles operate primarily within the confines of the Baker city limits although we are authorized to provide service throughout Fallon County.

Out-Of-Town Travel

We currently provide one regularly scheduled "group" trip per month. Individualized travel, with an emphasis on medical appointments, is provided within pre-established guidelines.
